**CCTV will be installed and operated in accordance with the Humberside Police codes of practice as set out below:**

- **A CCTV system which records in real time shall be installed and maintained at the premises.**
- **The system shall be in operation at any time when the premises are open to the public and for not less than 30 minutes after the premises close.**
- **There shall be a sufficient number of cameras to provide coverage of the bar area, including any place where alcohol is served, where payment is made, all entrances/exits and any outdoor areas.**
- **The system shall record images of evidential quality to be able to identify individuals and all recordings shall have a retention period of not less than 28 days.**
- **A monitor will be placed so as to be viewed by staff working in the sales area of the premises.**
- **The Designated Premise Supervisor will ensure that there is a staff member who is conversant and who has the capability to operate the CCTV system during all hours of trade.**
- **A copy of any recording shall be made available within 48 hours of a request to an officer under the direction and control of the Chief Constable of Humberside Police or an officer of the Licensing Authority upon production of proof of identity.**

**To remove the out of date condition under “The Protection of Children from Harm” Licensing Objective that “Children restricted to no smoking areas.”**

**All other currently permitted hours, activities and remaining conditions are to remain unchanged by this application.**
